Authorisation to use the trademarks of “Haier” or “海爾”

Qingdao Oasis, a subsidiary of the Company which is principally engaged in consumer electronic products is authorised to use the trademarks of “Haier” and “海爾” on all the childcare related products manufactured and traded by Qindgao Oasis in the PRC at nil consideration for a term up to 31 December 2016. The childcare related products include but not limited to baby care kit (electric steriliser, baby bottle & food warmer, infant formula preparation kit, food warmer, baby food processor), baby washing machine, baby air-conditioner, baby air-purifier, baby water purifier, baby refrigerator, children hair grooming products and related childcare electronic products.

The Directors considered that the authorised use of trademarks of “Haier” and “海爾” on the childcare related products by the Group would enable the Group to further develop the business related to children electronic appliances in the PRC. The trademarks of “Haier” and “海爾” are well-known brand name for consumer electronic products in the PRC and overseas with international presence, the Directors therefore considered that the use of trademarks of “Haier” and “海爾” on all the childcare related products of Qindgao Oasis will enhance our Group’s brand image and positively imply the quality standard of our childcare related products. The Directors believe that the use of trademarks of “Haier” and “海爾” on the childcare related products of the Group will have attractive prospects and growth potential and represents an important part of the Group’s development strategy. The Directors are of the view that the use of trademarks of “Haier” and “海爾” is in the interests of the Company and the Shareholders as a whole.
